- signed contract, copy of registration document of the company.

Requirements for registered debts:

- to fill the **Debt registration form**
- the payment deadline expired more than 30 days ago
- the debts have not been disputed
- no restrictions on the amount of the debt
- after registration the record can be deleted only by the administrator of **RiskStop Portal**.

**RiskStop Portal** includes data about payment defaults only on legal entities.
